





Transcranial Magnetic Stimulation

ADOPT MCG 28th edition Behavioral Health Guideline: "Transcranial Magnetic Stimulation"

RETIRE Magellan Healthcare Guideline: "Transcranial Magnetic Stimulation (TMS) Treatment"

- MCG 28th edition clinical guideline for "Transcranial Magnetic Stimulation" is consistent with Magellan Healthcare guideline:
 - Indications: Major depressive disorder (severe) AND
 - inadequate response to pharmacology despite adequate duration and dosage and trials from 2 or more classes of antidepressants; OR
 - inability to tolerate pharmacotherapy as evidenced by 2 trials of agents with documented side effects.
 - Use of standardized rating scales for measurement of depressive symptoms and changes in symptoms across course of treatment
 - Definition of positive response to treatment as reduction of at least 50% in depressive severity rating scale as compared to baseline
 - Exclusions for use of TMS, e.g. acute or chronic psychotic symptoms or disorders; no cochlear implant or deep brain stimulator, etc.
 - Inconclusive, non-supported evidence for other diagnoses (e.g. OCD, anxiety disorder, bipolar disorder) as well as for maintenance treatment to prevent relapse of major depressive disorder in remission

2) American Society of Addiction Medicine (ASAM) updates:




