Dr. Wadle is in private practice in Des Moines, Iowa at Wadle and Associates, P.C. He is board-certified in psychiatry, addictions and quality assurance. Dr. Wadle also is the medical director for Magellan Behavioral Care of Iowa and is on the Iowa Physicians Review Committee for the Iowa Board of Medical Examiners.

The **Nebraska Co-Occurring Task Force**, a sub-committee of the Metro Area Continuum of Care for the Homeless (MACCH) implemented a system change initiative in 2005 to address COD among the homeless and behavioral health community of provider organizations. They seek integrated treatment of mental illness and substance use disorders, in an effort to prevent homelessness, as well as provide the most efficient and effective array of services no matter the level of care being provided.

Shannon Mahnke is the project director for integrated treatment with Heartland Family Service. Her position entails the research, development, and implementation of programming to treat individuals with COD. Ms. Mahnke presides over the Co-Occurring Disorders Quality Improvement Team, which is responsible for the development and implementation of a quality improvement plan addressing the needs or gaps of clients with COD. Additionally, Ms. Mahnke takes part in the Co-Occurring Task Force of the Metro Omaha Continuum of Care.

Lori Hancock-Muck has more than 10 years of experience providing mental health and substance abuse treatment services. She has worked in various areas of the behavioral health field including mental health centers, outpatient substance abuse facilities, an employee & student assistance program, and a correctional facility. Ms. Hancock-Muck currently works as a quality improvement clinical reviewer with Magellan Health Services.
